- ___ 3. Heights of all retaining walls with spot elevations along wall at top and bottom. Wall heights between 4 and 6 feet will require a **Wall Indemnification Agreement** from the owner/builder or plans bearing a professional seal and signature of an Engineer having registration in the State of Georgia. For wall heights 6 feet and over, plans must bear a professional seal and signature of an Engineer having registration in the State of Georgia. **(Note: a copy of Wall Indemnification Agreement(s) will be required prior to approval).**
- ___ 4. How many walls require indemnification agreements?
- ___ 5. Indemnification agreements attached.
- ___ 6. Spot elevations for top and bottom of wall at all ends of and turns in each wall and at the highest anticipated wall height location.
- ___ 7. Additional existing and proposed topographic information may be required.
- ___ 8. If the use of walls is deemed excessive, wall heights are above normal, or apparent grading required to install the walls is considered extensive; applicant may be required to submit a Single Family Site Plan noting planned erosion and sediment control measures.
